Pension Legislation Passes, Governor Signs Bill into Law



After passage in both houses of the legislature, Senate Bill 1444 became law upon the governor's signature on May 29, 2023.

The legislation was a culmination of the joint effort between COAERS and the City of Austin to bring forward an agreed-upon, comprehensive framework for plan sustainability. In 2022, the COAERS Board of Trustees and the City of Austin developed a proposal to amend the COAERS governing statute to ensure the long-term financial sustainability of the retirement system. The collaborative effort between COAERS and the City resulted in Senate Bill 1444, which was introduced this past March at the start of the 88th Texas legislative session.

During the legislative session, COAERS Executive Director Christopher Hanson testified before both the Senate Finance Committee and the House Pensions, Investments and Financial Services Committee during their respective hearings of the bill.

The legislation touches on several policy areas, including contributions, benefits, and governance. The key provisions include:

- Moving to a flexible actuarially determined employer contribution rate, which can increase to keep the plan on a steady path toward full funding;
- Implementing a phased-in payment schedule for the City of Austin to pay off the Unfunded Actuarial Accrued Liability, or

"legacy liability," within a 30-year period;

- Increasing employee contributions by 2%, from 8% to 10%, over a two-year phase-in period.
- Modifying benefit policies such as service purchases that will mitigate the risk of future costs to the System. However, the bill does not make changes to the retirement benefits earned by members.
- Converting one elected active member COAERS Board position to a City of Austin appointed position; and
- Requiring support from both COAERS and the City of Austin for future cost-of-living adjustments.

The provisions of the bill are expected to have a significantly positive impact on the funding of the System in future years. Most notably, the legislation will retire the System's unfunded liability over a fixed 30-year period, increase employee contributions to the System, and move the System to a flexible actuarially determined employer contribution rate to keep the plan on a steady path toward full funding and continue to provide members their promised benefits.

The law will go into effect on September 1, 2023. However, the provisions related to benefits and contributions will take effect January 1, 2024.

Benefits 101: What is Vesting?

Vesting is an important milestone toward a secure financial future. It means you have established enough service credit to receive a lifetime benefit once you reach retirement eligibility.

When are you vested?

You are considered vested if you have at least five years of service credit and do not withdraw your accumulated contributions if you terminate City employment. If you have service credit with a retirement system that participates

in the Proportionate Retirement Program, that service may count toward the five years of service credit needed for vesting.

What happens if you're not vested?

If you leave City employment with less than five years of service credit, there are several options available to you.

Member may leave their accrued contributions on deposit with the retirement system, obtain a refund to have your contributions refunded to you, or roll the contributions over to the City's deferred compensation or any other qualified plan such as an IRA, 401k, etc.

COAERS Announces New Headquarters Move

The COAERS Board of Trustees announced that the retirement system will move its current northwest Austin offices located in the Northpoint Centre complex near Far West Boulevard and Mopac to 4700 Mueller Blvd, a commercial office building located in the Mueller District. The retirement system anticipates transitioning to its new headquarters in 2024.

In alignment with its fiduciary duties, the COAERS Board

evaluated the System's long-term facilities needs to serve its members, enhance operations, and streamline costs, and 4700 Mueller fulfills those criteria.

"The property's location, facilities, and the ability to meet our organizational, staffing, and member needs, now and in the future, make it an excellent long-term capital asset for COAERS," said Executive Director Christopher Hanson. "The move will help COAERS continue to drive value for our members and better

achieve our goal to provide them with high-quality services, education, and experiences."

Built in 2007, the property will provide additional space to expand retirement planning and counseling services and events for COAERS members to access, and it will consolidate COAERS staff in one building. For more information, please visit www.coaers.org/coaers-announces-new-headquarters-move.
