COAERS offers direct deposit to members to ensure that monthly benefit payments and refunds are securely delivered. Electronic transfers via direct deposit are efficient, reliable, safe, and eliminate the possibility of delayed payments or lost checks. # **COAERS Launches New Virtual Tools for Remote Service to Members**

This June, COAERS announced the launch of two new online services to provide new ways for members and retirees to connect remotely, including virtual seminars and virtual counseling sessions.

# Pre-Retirement Virtual Seminar

On June 24, COAERS will kick off its Pre-Retirement Virtual Seminar event, a new web-only series of seminars using a secure online video platform. Active COAERS Members nearing retirement can register for the online event and will have the opportunity to participate in an interactive, live web presentation hosted by a Member Services Specialist. Like past pre-retirement seminars, the virtual event will provide valuable information to COAERS members about the retirement process, retirement eligibility, retirement benefit payments, service and service credits, and much more. ### Virtual Visits with COAERS

COAERS now offers Virtual Visits - secure, online one-on-one counseling sessions for members to meet remotely with our Member Services team. Virtual Visits will allow COAERS members to meet face-to-face with a Member Services Specialist from the comfort of your home or office through secure, virtual conferencing. Just like in-person office visits, members can use Virtual Visits to learn about benefits, receive personalized estimates, process requests, and review benefit payment options and more. Webcams are an option if you would like the Member Services Specialist to be able to see you during the virtual visit, but they are not required. # July Actuarial Assumptions Changes Postponed

During the March 31 meeting of the COAERS Board of Trustees, the Board voted to postpone implementing the recent changes in actuarial assumptions, which were scheduled to go into effect on July 1, 2020.

As a result of the Board's decision to delay implementing the changes, COAERS will continue to use its current methods of calculating benefits so our members don't have to worry about calculations changing after July 1, 2020 if they request an estimate for a service purchase, a future retirement annuity with a partial lump sum payment, or a future joint and survivor annuity. Furthermore, members who are seeking to purchase service credit will no longer see large cost increases to service purchases made on or after July 1, 2020.

As the Board of Trustees reevaluates any future implementation of actuarial assumption changes, we will continue to keep our membership well-informed of these decisions and provide advanced notice of any decision made by the Board. The new implementation date for actuarial assumptions will be posted to our website first, so bookmark www.coaers.org for the latest news.
